(a) Very Important Steps:-

You have to fill Two forms given below:-

- (i) **For Eligibility Purpose:-** You must again check your eligibility from the prospectus of MBA 2025 before filling the Admission form on https://mbacdoe.puchd.ac.in/
- (ii) For Examination/DEB ID integrated purpose:- Admission cum Examination Form will be available at https://cdoeadmissions.puexam.in/ at the time of Counseling after confirmation of admission. (If you do not fill this form you will not be issued the roll no.)
- (b) Physical presence of the candidate is must at the time of counseling.
- (c) Mandatory Documents Required for Counseling (Hard Copy).
 - i. ABC ID (Academic Bank of Credit) through Digilocker App (Mandatory)
 - ii. Candidate who have cleared the entrance test and are desirous of taking admission in MBA CDOE (2025-26) are advised to first create ABC ID and then DEB ID in admission form.
 - iii. Print out of ABC ID
 - iv. Print out of DEB ID
 - v. Copy of Aadhar Card.
 - vi. Two hard copies of Admission Form
 - vii. Hard Copy of Enrolment Card.
 - viii. Original certificates of Bachelors degree, DMC's of all semesters, reserved category certificate (if any).
 - ix. One set of attested photocopy of certificates of the qualifying examination DMC/Degree on the basis of which you are seeking admission.
 - x. Migration certificates for other than Panjab University students. (Migration certificate can be submitted within a month or by 12th September, 2025).
 - xi. Two recent passport size photographs
 - xii. Confidential Result: Students appearing in the Final year examination to submit at the time of counseling or by 12th September, 2025.
 - xiii. Any Discrepancy by the Candidate by 12th September, 2025.

 - (iii) Eligibility Fees = 75/- (To be paid by those candidates who have passed the lower examination from the University/Board other than Panjab University).
 - (iv) Migration Fees = 1100/- P.A. (To be paid by those candidates who have lower examination from other University and Boards except CBSE, ICSE, PANJAB, HARYANA & HIMACHAL BOARD).
